The Russell County Commission Russell County Commission Chambers Meeting Minutes September 23, 2020 9:30 A.M. EDT

An adjourned meeting of the Russell County Commission was called to order by Chairman Lee.

Chairman Lee welcomed everyone for their attendance.

The invocation was given by Commissioner Martin.

Commissioner Cattie Epps led the Pledge of Allegiance.

PUBLIC COMMENTS:

Mr. Willie Carnes talked about flooding in his neighborhood.

Ron Jones with the American Legion Post 135 awarded the Commission for its support with Hurricane Laura.

Jennifer Davidson with the Russell County Extension Office gave the annual report.

County Administrator LeAnn Horne called roll. Members present were Chairman Gentry Lee, Commissioner Peggy Martin, Commissioner Ronnie Reed, Commissioner Cattie Epps, Commissioner Chance Corbett, and Commissioner Larry Screws. Also, present was the County Attorney Kenneth Funderburk. Commissioner Carl Currington was absent. A quorum was established.

APPROVAL OF MINUTES:

Chairman Lee stated: We will postpone the approval of the August 26, 2020 and the September 9, 2020 minutes until the next Commission Meeting.

PROCLAMATIONS AND RESOLUTIONS:

Commissioner Corbett motioned to approve a Posthumous Proclamation for former Russell County Commissioner, J.D. Upshaw. Commissioner Martin motioned to approve. The vote was unanimous.

DISCUSSION ITEMS:

Commissioner Corbett discussed Russell County business growth. He made a motion to request a quarterly report from Victor Cross with the business growth in Russell County. Commissioner Corbett made a motion to add to Business. There was not a second motion. The motion dies without a second.

Chairman Gentry Lee reminded the Commissioners that the position of the Assistant County Administrator has not been filled since January. It is normally the Bookkeeper's position, but it still has to go through the Commission. This is a Commission appointment. It is an important position. The position is to deal with budget, finances and fill in when the Administrator is out.

Commissioner Martin recognized Cindy Jeanes with the Department of Human Resources. Ms. Jeanes was requesting a donation for a Christmas project to help with families. Chairman Lee motioned to give \$500 out of his discretionary fund starting in October to be allocated to this program. Commissioner Reed seconded the motion and gave \$500. Commissioner Corbett gave \$500 and Commissioner Martin gave \$500. This was a total of \$2,000.

Maintenance Director Leon Watson requested a budget transfer. Commissioner Corbett motioned to approve. Seconded by Commissioner Martin. The vote was unanimous.

Sheriff Heath Taylor requested approval to send out bids for uniforms. The bids would be sent out September 25, 2020, due and opened on October 22, 2020 at 3:00 P.M. in the Commission Chamber. Commissioner Corbett motioned to approve. Seconded by Commissioner Reed. The vote was unanimous.

Chief Mapper and Appraiser Heath Crowe requested a budget transfer. Commissioner Epps motioned to approve. Seconded by Commissioner Reed. The vote was unanimous.

Judge Alford Harden requested approval to change polling places from Roy Martin Center to Idle Hour Park Community Center and from the Fire Department, EMA building to the Phenix City Youth Center. Commissioner Screws motioned to approve. Seconded by Commissioner Reed. The vote was unanimous.

Judge Alford Harden reminded everyone to please complete the 2021 Census.

County Administrator Leann Horne requested the approval for 2021 Russell County Budget. There was a salary increase of 3 percent. Commissioner Reed motioned to approve. Seconded by Commissioner Screws. District 1 (Lee) voted, yes; District 3 (Martin) voted, yes; District 4 (Reed) voted, yes; District 5 (Epps) voted, yes; District 6 (Corbett), abstained; District 7(Screws) voted, yes. There were 5 yes votes and one abstention. The motioned passed.

County Administrator Leann Horne requested the approval of the 2021 Salary Schedule. Commissioner Lee asked Sheriff Heath Taylor if his salary schedule is the same as everyone else? Sheriff Heath Taylor said his was based on the performance evaluation he gave his employees. He gave every employee in his department a 2 percent cost of living raise. The employees that were employed less than six months did not get the 1 percent. The employees that had the evaluation got the additional 1 percent. Chairman Lee made it clear by doing it this away the Elected Commissioners will only get 2 percent. County Administrator Horne stated: Not all of them. The Elected Officials other than the ones that did not get a State Legislative raise will get the raise under the Omnibus Pay Act. This is what the auditors told the Commissioners per Chairman Lee. The Legislature approved a raise until the money is used up by 3 percent you do not get one. Commissioner Reed motioned to approve. Seconded by Commissioner Screws. The vote was unanimous to approve the Salary Schedule.

Announcements were made.

Chairman Lee moved for the meeting to be adjourned.
