

The Russell County Commission
Meeting Minutes
December 26, 2018
9:30 A.M. EST

An adjourned meeting of the Russell County Commission called the reconvened Chair Martin called the meeting to order. Commissioner Epps motioned to approve. Seconded by Commissioner Reed. The vote was unanimous.

Chair Peggy Martin gave the invocation.
