

The Russell County Commission  
Meeting Minutes  
September 25, 2019  
9:30 A.M. EST

An adjourned meeting of the Russell County Commission was called to order.

Chair Martin led the audience in prayer.

Commissioner Ronnie Reed led the Pledge of Allegiance.

**PUBLIC COMMENTS:**

Jennifer Davidson stated: Thank you for the support that Russell County Extension receives especially for 4-H. Jennifer gave all Commissioners yard signs for 4-H.

Chair Martin thanked Cable T.V. of East Alabama and the Citizen of East Alabama for their coverage of the Commission Meetings. She also welcomed Elected Officials, Department Heads, Media and Guests.

Assistant County Administrator Vickie Perry called roll. Members present were; Chair Peggy Martin, Vice Chair Cattie Epps, Commissioner Gentry Lee, Commissioner Carl Currington, Commissioner Ronnie Reed and Commissioner Larry Screws. Also, present was the County Attorney Kenneth Funderburk. A quorum was established. Commissioner Chance Corbett was absent.
